INVITATION FOR EXPRESSION OF INTEREST (EOI)

PURCHASING FUEL BARGES

2. Criteria for shortlisting applications.

a. Applicants shall be shipbrokers, shipowners, or should have experience or involvement in the purchase and sale of barges or vessels.

3. Submission of EOI.

- a. Applications for this EOI will only be accepted from individual companies, not joint ventures.
- b. The EOI shall be type written and signed by the applicant or a person or persons, duly authorized by the applicant to submit the proposal.
- c. The applicant shall submit their EOI via email to tenders@sto.mv clearly subjected "Purchase of Fuel Barges"
- d. Deadline for submission is 11th June 2024, 1600hrs, Maldives Time.
- e. STO may, at its discretion, extend this deadline for the submission of the EOI, in which case all rights and obligations of STO and applicants previously subject to the deadline will thereafter be subject to the deadline as extended.
- f. Any EOI received by STO after the deadline for submission of EOI will be rejected.
