- 2.3 The applicant must not be blacklisted or debarred by the Ministry of Finance and must not have any unresolved issues with the Ministry of Economic Development or MIRA.

- 3.1 Reference letter/work completion certificates or any documentation in the name of Companies/Government Entities/Institutions/Commission etc. (any legal or government entity) for successful completion of at least one similar nature of project involving construction works.
- 3.2 The applicant must not be a Blacklisted / Default/ Legal Customer of State Trading Organization Plc. or any subsidiaries of State Trading Organization Plc.
- 3.3 The applicant must not be blacklisted or debarred by the Ministry of Finance and must not have any unresolved issues with the Ministry of Economic Development or MIRA.

- 4.1 Company certificates (Registration certificate, Memorandum of association, Articles of association, Business information sheet, Bank details, Identity card of business shareholders, MIRA TAX clearance report and registration certificate).
