2. <u>Criteria for shortlisting applications.</u>

- a) The applicant must have successfully completed at least one project of a similar nature, involving design and PMC for a mixed-use commercial building, with a minimum value of USD 500,000 (five hundred thousand United States Dollars) or its equivalent, within the past ten years.
- b) The applicant must not be a Blacklisted / Default/ Legal Customer of State Trading Organization Plc. or any subsidiaries of State Trading Organization Plc.
- c) The applicant must not be blacklisted or debarred by the Ministry of Finance and must not have any unresolved issues with the Ministry of Economic Development or MIRA.

3. <u>Submission of EOI</u>.

- a. The EOI shall be type written and signed by the applicant or a person or persons, duly authorized by the applicant to submit the proposal.
