- 1.2 Implement effective pest control measures to eliminate and prevent infestations.
- 1.3 Ensure the long-term prevention of pests through regular monitoring and maintenance.

2. <u>The Eligible Tenderers are limited to:</u>

- 2.1 The applicant must provide evidence of providing similar pest treatments within the past one year.
- 2.2 The applicant must not be a Blacklisted / Default/ Legal Customer of State Trading Organization Plc. or any subsidiaries of State Trading Organization Plc.
- 2.3 The applicant must not be blacklisted or debarred by the Ministry of Finance and must not have any unresolved issues with the Ministry of Economic Development or MIRA.

3. Eligibility of the proponent will be validated by:

3.1 Reference letter/work completion certificates or any documentation in the name of Companies/Government Entities/Institutions/Commission/Resort Retainers etc. (any legal or government entity) which proves bidders' engagement in the proposed similar nature of pest related works.
