- 2.1 The applicant must have a minimum of 3 years of experience in uniform stitching for corporate or retail clients.
- 2.2 The applicant must not be blacklisted or debarred by the Ministry of Finance or STO and must not have any unresolved issues with the Ministry of Economic Development or MIRA.

- 3.1 Eligibility of the proponent will be validated through reference letters, work completion certificates, or any other documentation (such as photographs) issued by companies, government entities, institutions, commissions, or resort retainers, demonstrating the bidder's engagement in similar types of work. Reference letters from individuals will not be accepted.
