INVITATION FOR TENDER

HIRING A CONSULTANT TO PROVIDE CONSULTANCY SERVICES FOR MULTISTOREY WAREHOUSE DEVELOPMENT PROJECT

1. Service Required

1.1 The Consultant shall prepare the Employer's Requirements and provide Project Management Consultancy (PMC) for the EPC contract of the Multi-Storey warehouse project as per the Scope of Works document.

2. The Eligible Tenderers are limited to:

- 2.1 The applicant must provide evidence of completing at least one similar project where the value of the consultant's service was MVR 250,000 or above within the past ten years.
 - 2.1.1 The Local applicant shall be the leading entity and focal party of the project and retains full responsibility for project delivery.
 - 2.1.2 Evidence of such affiliation, including role descriptions and organizational responsibility, must be submitted.
- 2.2 The applicant must not be a Blacklisted / Default/ Legal Customer of State Trading Organization Plc. or any subsidiaries of State Trading Organization Plc.
- 2.3 The applicant must not be blacklisted or debarred by the Ministry of Finance and must not have any unresolved issues with the Ministry of Economic Development or MIRA.
- 2.4 Foreign firms can participate as Joint ventures / affiliated technical partners.

3. Eligibility of the proponent will be validated by:

3.1 Reference letter/work completion certificates or any documentation in the name of Companies/Government Entities/Institutions/Commission etc. (any legal or government entity) which proves bidders' engagement in the preparation of Employers requirements, project management consultancy, or similar nature of consultancy services for building construction projects of comparable scale.
